




Figure 2. Typical forward characteristics in surge current





Figure 4. Power dissipation






Figure 5. Diode forward current

Figure 6. Maximum transient thermal impedance



















Figure 7. Capacitance vs. reverse voltage at 1MHz

Figure 8. Typical capacitive charge vs. reverse voltage




Figure 9. Typical capacitance stored energy vs. reverse voltage

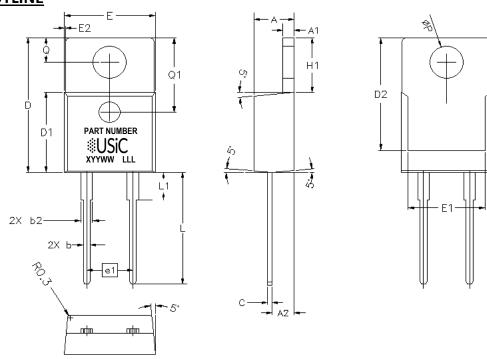

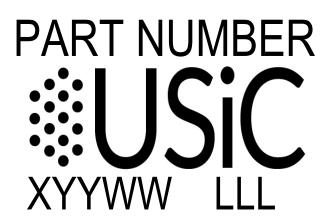
